




The "State Costs Avoided" of over \$20.6 million represents the total amount the state has saved through its longstanding partnership with NIC Montana and the use of the Self-Funded Model since 2001. This reflects costs avoided for initial development as well as the ongoing maintenance of most eGovernment services and other related eGovernment activities. Additional services are also provided to our state partners at no cost under the Self-Funded Model including but not limited to: Customer Service, 24/7 Monitoring, Hosting (in most cases), Testing, Marketing, Project Oversight, Ongoing Maintenance, Mobile Opportunities, Application Scans, Security, State-of-the-Art Infrastructure, Sox & Financial Compliance, Financial Reconciliation, SABHRS Integration and Disaster Recovery.



MY VOTER PAGE APPLICATION LOGS LARGE


TRAFFIC SPIKE: Montanans fully embraced the idea of accessing election information online in 2020 as illustrated by the huge increase in traffic when comparing user sessions on the My Voter Page (MVP) application this election year with the last federal election year. The MVP application allows Montana citizens to view their voting status, physical polling location (if offered), and a sample ballot specific to their county. In Q3, users visited MVP more than 150,000 times, compared to just 15,400 times in Q3 2016, resulting in an 877% increase. The Montana Secretary of State's (SOS) office worked with NIC Montana throughout Q3 in preparation for the 2020 election, updating the application to now allow users from mail-in-only counties to view information. Prior to this



quarter's updates, the application only provided information for physical in-person polling locations. The SOS also updated sample ballots for each of the state's 56 counties, including counties with split ballots. In conjunction with the SOS and the State Information Technology Service Division's (SITSD) Security Enterprise Risk Bureau, NIC Montana fine-tuned security, which included conducting multiple application scans.

MORE COUNTIES ADDING BURN PERMIT SERVICE: Beaverhead County signed up to add the County Burn Permit application to its online portfolio in Q3. Beaverhead County citizens now can buy a burn permit without leaving home. Developed in partnership with NIC Montana, the County Burn Permit service is available online at burnpermits.mt.gov. Through the website, citizens have instant access to purchase permits, add multiple burn locations to a single permit, and print permits at home or send permits to themselves electronically by email. The online service accepts both debit and credit cards as well as electronic checks. Citizens can activate permits online or by calling an automated phone system. The Burn Permit service displays real-time updates on an interactive county map when a customer activates a permit by entering the permit number and the start and stop times of the burn. County fire and emergency personnel use the service to monitor current burn activity within the county. Since launching in 2009, 18 counties have begun using the NIC Montana application, which has diverted more than 453,000 calls from emergency county personnel. Two additional counties have expressed interest in adding the service in 2020, bringing the total to 20 active counties.

COVID BEST PRACTICES CONTINUE TO SPUR ONLINE INTERACTION WITH GOVERNMENT: As the effects of the COVID-19 pandemic spread across Montana this summer, government offices across the State continued to limit public interaction and provide services with reduced staff. Citizens and businesses looked to NIC Montana-partnered online applications to accomplish tasks such as renewing vehicle registrations, purchasing hunting and fishing licenses, and paying for livestock permits. In Q3, visitors to NIC Montana-partnered services interacted with the portal's applications nearly two million times. The Department of Justice's Temporary Registration Permit (TRP) application, the



Secretary of State's My Voter Page (MVP), and the Department of Labor's Prescription Drug Registry (PDR) all broke records for the most visits for second consecutive quarter. Additionally, NIC Montana processed nearly \$300,000 on behalf of eight partner agencies through its highly successful AccessGov solution in Q3. During this three-month period, Department of Livestock customers submitted 1,866 paid transactions through AccessGov, while Missoula County citizens and Miles Community College students submitted 681 and 635 payments, respectively. While eight Montana government agencies use AccessGov to collect data and accept payments, 16 agencies have not added any payment

configurations to their forms, but still are using the solution to collect submissions and provide information to constituents. In Q3, Montanans submitted more than 21,300 forms through AccessGov. Some agencies prefer to review AccessGov submissions before requesting payment and use NIC's Prompt Pay application to invoice constituents via email or text message. More than 3,600 customers from Cascade, Gallatin, Lewis and Clark, Missoula, and Yellowstone counties submitted \$2.2 million through Prompt Pay in Q3.




