6 A BILL FOR AN ACT ENTITLED: "AN ACT GENERALLY REVISING 9-1-1 LAWS; ESTABLISHING A 9-1-1  
7 ADVISORY COUNCIL; ESTABLISHING 9-1-1 ADVISORY COUNCIL AND DEPARTMENT OF  
8 ADMINISTRATION DUTIES FOR 9-1-1 SYSTEMS AND SERVICES; PROVIDING RULEMAKING AUTHORITY;  
9 CLARIFYING LOCAL GOVERNMENT AND 9-1-1 DISTRICT ROLES; PROVIDING DEFINITIONS; UPDATING  
10 TERMS TO INCLUDE NEXT-GENERATION 9-1-1; REVISING THE ALLOCATION OF 9-1-1 FEES; REQUIRING  
11 THE DEPARTMENT OF ADMINISTRATION TO UPDATE THE ALLOCATION OF 9-1-1 FEES IN ACCORDANCE  
12 WITH THE DECENNIAL CENSUS; ESTABLISHING ACCOUNTS FOR DISTRIBUTION OF 9-1-1 FUNDS;  
13 REQUIRING THAT CERTAIN FEES COLLECTED FOR 9-1-1 SERVICES BE REALLOCATED UNDER  
14 CERTAIN CIRCUMSTANCES; ESTABLISHING A REALLOCATION PROCESS; ESTABLISHING A  
15 NEXT-GENERATION 9-1-1 INFRASTRUCTURE ACCOUNT; CREATING A NEXT-GENERATION 9-1-1  
16 INFRASTRUCTURE GRANT PROGRAM; PROVIDING CRITERIA TO THE DEPARTMENT OF  
17 ADMINISTRATION FOR AWARDING NEXT-GENERATION 9-1-1 INFRASTRUCTURE GRANTS;  
18 ESTABLISHING A 9-1-1 GIS MAPPING ACCOUNT; REQUIRING THE STATE LIBRARY TO AWARD A  
19 CONTRACT FOR A GIS ASSESSMENT; ESTABLISHING A STATEWIDE 9-1-1 PLANNING ACCOUNT;  
20 REQUIRING THE DEPARTMENT TO AWARD A CONTRACT TO DEVELOP A STATEWIDE 9-1-1 PLAN;  
21 ESTABLISHING A PRIVATE TELECOMMUNICATIONS PROVIDER AND LOCAL GOVERNMENT 9-1-1 GRANT  
22 PROGRAM; PROVIDING PRIORITIES AND CRITERIA FOR THE 9-1-1 GRANT PROGRAM; TRANSFERRING  
23 FUNDS; AMENDING SECTIONS 10-4-101, 10-4-103, 10-4-201, 10-4-301, 10-4-302, 10-4-313, AND 17-7-502,  
24 MCA; REPEALING SECTIONS 10-4-102, 10-4-104, 10-4-111, 10-4-112, 10-4-113, 10-4-114, 10-4-115, 10-4-121,  
25 10-4-125, 10-4-126, 10-4-301, 10-4-302, 10-4-303, 10-4-311, 10-4-312, AND 10-4-313, MCA; AND PROVIDING  
26 EFFECTIVE DATES AND A TERMINATION DATE."

27  
28 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MONTANA:

29  
30 NEW SECTION. **Section 1. 9-1-1 advisory council.** (1) There is a 9-1-1 advisory council.



- 1 (2) The council consists of 17 members appointed by the governor as follows:
- 2 (a) the director of the department or the director's designee, who serves as presiding officer of the
- 3 council;
- 4 (b) a representative of the department of justice, Montana highway patrol;
- 5 (c) a representative of the Montana emergency medical services association;
- 6 (d) three representatives of Montana telecommunications providers;
- 7 (e) a representative of the Montana association of public safety communications officials;
- 8 (f) two public safety answering point managers, one serving a population of less than 30,000 and one
- 9 serving a population of greater than 30,000;
- 10 (g) a representative of the department of military affairs, disaster and emergency services division;
- 11 (h) a representative of the Montana association of chiefs of police;
- 12 (i) a representative of the Montana sheriffs and peace officers association;
- 13 (j) a representative of the Montana state fire chiefs' association;
- 14 (k) a representative of the Montana state volunteer firefighters association;
- 15 (l) a representative of the Montana association of counties;
- 16 (m) a representative of the Montana league of cities and towns; and
- 17 (n) the state librarian or the state librarian's designee.
- 18 (3) The council is attached to the department for administrative purposes only, as provided in 2-15-121.
- 19 (4) The council shall, within its authorized budget, hold quarterly meetings.
- 20 (5) Council members shall serve without additional salary but are entitled to reimbursement for travel
- 21 expenses incurred while engaged in council activities as provided for in 2-18-501 through 2-18-503.
- 22

23 **NEW SECTION. Section 2. 9-1-1 advisory council duties -- consultation by department.** The 9-1-1

24 advisory council shall:

- 25 (1) advise the department in its duty to allocate and distribute 9-1-1 fees in accordance with [section 7]
- 26 and to update the allocation and distribution in accordance with rules adopted pursuant to [section 4(3)];
- 27 (2) provide recommendations to the department in determining grants awarded in accordance with
- 28 [section 8];
- 29 (3) advise the department in the development of a statewide 9-1-1 plan; and
- 30 (4) advise the department on significant matters concerning 9-1-1 systems development and 9-1-1

1 services in the state of Montana, including rulemaking.

2

3 **NEW SECTION. Section 3. Department duties and powers -- 9-1-1 planning.** (1) There is a 9-1-1

4 program administered by the department.

5 (2) The department shall:

6 (a) allocate and distribute 9-1-1 fees;

7 (b) update the allocation and distribution of 9-1-1 fees in accordance with [section 7] and rules adopted

8 pursuant to [section 4];

9 (c) provide grants in accordance with [section 8]. In awarding the grants, the department shall review  
10 and approve requests for funding in accordance with [section 8].

11 (d) monitor the expenditure of program funds for:

12 (i) 9-1-1 purposes by local governments that host public safety answering points; and

13 (ii) allowable uses of grant funds by entities;

14 (e) establish a statewide 9-1-1 plan in accordance with subsection (3) and planning completed in  
15 accordance with [section 13];

16 (f) staff and fund the administrative costs of the 9-1-1 advisory council established in [section 1]; and

17 (g) accept federal funds granted by congress or by executive order and gifts, grants, and donations for  
18 the purposes of administering this chapter.

19 (3) A statewide 9-1-1 plan must include:

20 (a) to the maximum extent feasible the use of existing commercial communications infrastructure; and

21 (b) 9-1-1 system standards and support efforts to migrate legacy technologies to next-generation 9-1-1  
22 technologies when appropriate and to provide for the implementation of future 9-1-1 technologies. Any standards  
23 adopted by the department for legacy 9-1-1 technologies or principles adopted for baseline next-generation 9-1-1  
24 technologies must be:

25 (i) flexible and graduated, while ensuring minimum service levels; and

26 (ii) based on industry standards.

27 (4) The department, in fulfilling its duties pursuant to subsection (2), may request necessary information  
28 from local governments. If a local government does not comply with the request, the department may withhold  
29 funding distributions as provided for in [section 5].

30

1            **NEW SECTION. Section 4. Rulemaking authority.** (1) Before July 1, 2018, the department shall adopt  
2 rules to implement the provisions of this chapter. The rules must include but are not limited to:

3            (a) distribution procedures for funding authorized in [section 7(1)];

4            (b) procedures for grant funding authorized in [section 8]. The rules for grant funding must include but  
5 are not limited to:

6            (i) eligibility requirements for entities applying for grants;

7            (ii) criteria for awarding grants; and

8            (iii) reporting procedures for grant recipients;

9            (c) postdisbursement activities by the department to monitor the use of funding by entities, including:

10           (i) reporting requirements; and

11           (ii) procedures for repayment of funds expended on activities determined not to meet eligibility  
12 requirements.

13           (2) Before January 1, 2019, the department shall adopt rules including but not limited to:

14           (a) technology standards, based on industry standards and a statewide 9-1-1 plan pursuant to [section  
15 13], to ensure that public safety answering points meet minimum 9-1-1 services levels; and

16           (b) baseline next-generation 9-1-1 principles to facilitate the appropriate deployment of baseline  
17 next-generation 9-1-1.

18           (3) Before January 1, 2022, the department shall adopt rules for the allocation and distribution of funds  
19 in the account provided for in [section 6(2)(a)] in accordance with [section 7(2) and (3)] to local government  
20 entities that host public safety answering points.

21           (a) The rules adopted for allocation must be based on the official final decennial census figures and must  
22 ensure that each local government entity that hosts a public safety answering point receives funding. The  
23 allocation must account for:

24           (i) historic allocations provided to a local government entity that hosts a public safety answering point;

25           (ii) the population of counties, cities, or other government entities served by the public safety answering  
26 point;

27           (iii) population trends; and

28           (iv) other factors determined by the department, in consultation with the 9-1-1 advisory council provided  
29 for in [section 1], critical to the funding allocation.

30           (b) The department's allocation may not distribute funds in a manner that discourages public safety

1 answering points from consolidating or combining.

2 (4) The department shall adopt rules in accordance with the Montana Administrative Procedure Act  
3 provided for in Title 2, chapter 4, to implement the provisions of this section.

4  
5 **NEW SECTION. Section 5. Local government entities and funding -- department delegation.** (1)

6 After the department determines baseline next-generation 9-1-1 principles in accordance with rules adopted  
7 pursuant to [section 4(2)] and a statewide 9-1-1 plan, the department shall delegate implementation to local  
8 government entities that host public safety answering points.

9 (2) If the department determines through its monitoring process that a local government entity that hosts  
10 a public safety answering point is not using funds in the manner prescribed in this chapter or has failed to provide  
11 information required by the department, the department may, after notice and hearing, suspend payment to the  
12 local government entity. The local government entity is not eligible to receive funds until the department  
13 determines that the local government is complying with department requirements or has provided the requested  
14 information.

15 (3) Nothing in this chapter prevents a local government entity that hosts a public safety answering point  
16 from exceeding legacy technology standards or baseline next-generation 9-1-1 principles.

17  
18 **NEW SECTION. Section 6. Establishment of 9-1-1 accounts.** (1) Beginning July 1, 2018, there is  
19 established in the state special revenue fund an account for fees collected for 9-1-1 services pursuant to  
20 10-4-201.

21 (2) Funds in the account are statutorily appropriated to the department, as provided in 17-7-502. Except  
22 as provided in subsection (3), beginning July 1, 2018, funds that are not used for the administration of this chapter  
23 by the department are allocated as follows:

24 (a) 75% of the account must be deposited in an account for distribution to local government entities that  
25 host public safety answering points in accordance with [section 7] and with rules adopted by the department in  
26 accordance with [section 4]; and

27 (b) 25% of the account must be deposited in an account for distribution in the form of grants to private  
28 telecommunications providers, local government entities that host public safety answering points, or both in  
29 accordance with [section 8].

30 (3) Beginning July 1, 2018, all money received by the department of revenue pursuant to 10-4-201 must

1 be paid to the state treasurer for deposit in the appropriate account.

2 (4) The accounts established in subsections (1) and (2) retain interest earned from the investment of  
3 money in the accounts.

4  
5 **NEW SECTION. Section 7. Distribution of 9-1-1 systems account by department.** (1) Beginning July  
6 1, 2018, and for each quarter after that until the first quarter of the 2023 fiscal year, the department shall distribute  
7 the total quarterly balance of the account provided for in [section 6(2)(a)] as follows:

8 (a) each local government entity that hosts a public safety answering point must receive an allocation  
9 of the total quarterly balance of the account equal in proportion to the quarterly share received by the local  
10 government entity that hosts the public safety answering point during the 2017 fiscal year;

11 (b) each local government entity that hosts a public safety answering point must receive an allocation  
12 in accordance with subsection (1)(a). The allocation may vary from the amount distributed during the 2017 fiscal  
13 year based on the amount collected by the department of revenue in accordance with 10-4-201(1)(a).

14 (2) Beginning July 1, 2022, and in accordance with subsection (3), the department shall allocate and  
15 distribute the total quarterly balance of the account provided for in [section 6(2)(a)] based on rules adopted by  
16 the department in accordance with [section 4(3)].

17 (3) Within 1 year after the official final decennial census figures are available, the department shall  
18 update the rules establishing the quarterly allocation and distribution provided for in subsection (2) and allocate  
19 and distribute the quarterly balance for each quarter after that until the next update.

20  
21 **NEW SECTION. Section 8. 9-1-1 grants.** (1) The department shall, in consultation with the 9-1-1  
22 advisory council created pursuant to [section 1], award competitive grants annually using the account established  
23 pursuant to [section 6(2)(b)] for private telecommunications providers and for local government entities that host  
24 public safety answering points. Beginning July 1, 2018, grants must be awarded to private telecommunications  
25 providers, local government entities that host public safety answering points, or both in accordance with this  
26 section and with rules adopted by the department in accordance with [section 4].

27 (2) In accordance with subsection (3), grants may be awarded to private telecommunications providers  
28 and to local government entities that host public safety answering points for:

29 (a) emergency telecommunications systems plans;

30 (b) project feasibility studies or project plans;

1 (c) the implementation, operation, and maintenance of 9-1-1 systems, equipment, devices, and data;  
2 and

3 (d) the purchase of services that support 9-1-1 systems.

4 (3) In awarding grants, preference must be given to applications in the following order of priority:

5 (a) requests by private telecommunications providers or by local government entities that host public  
6 safety answering points by working with a private telecommunications provider; and

7 (b) requests by local government entities that host public safety answering points.

8 (4) Nothing in this section prevents a local government entity that hosts a public safety answering point  
9 in accordance with this section from:

10 (a) providing grant money received by the local government entity to a private telecommunications  
11 provider for 9-1-1 purposes; or

12 (b) collaborating with another local government entity on a joint grant application.

13

14 **NEW SECTION. Section 9. Baseline next-generation 9-1-1 account transfers.** (1) After the  
15 department makes distributions for the final quarter of the 2017 fiscal year from the wireless enhanced 9-1-1  
16 account established in 10-4-301(1)(c), the department shall transfer:

17 (a) \$5 million into the next-generation 9-1-1 infrastructure account established in accordance with  
18 [section 10];

19 (b) \$80,000 into the 9-1-1 GIS mapping account established in accordance with [section 12]; and

20 (c) \$350,000 into the statewide 9-1-1 planning account established in accordance with [section 13].

21 (2) The allocations in subsection (1) may be used only in accordance with [sections 10 through 13].

22

23 **NEW SECTION. Section 10. Next-generation 9-1-1 infrastructure account created -- source of**  
24 **funding -- use of account.** (1) There is an account in the state special revenue fund to be known as the  
25 next-generation 9-1-1 infrastructure account.

26 (2) There must be deposited in the account:

27 (a) money received from legislative allocations;

28 (b) a transfer of money in accordance with [section 9(1)(a)] for the purposes of [section 11]; and

29 (c) a gift, donation, grant, legacy, bequest, or devise made for the purposes of [section 11].

30 (3) Except as provided in subsection (4), the account may be used only by the department to provide

1 grants for next-generation 9-1-1 infrastructure as provided in [section 11] to a local government entity working  
2 with a private telecommunications provider.

3 (4) At the end of fiscal year 2019, any unexpended balance in the account must be transferred to the  
4 account established by the department in accordance with [section 6(2)(b)].

5  
6 **NEW SECTION. Section 11. Next-generation 9-1-1 infrastructure grants -- criteria -- rulemaking.**

7 (1) Money deposited in the next-generation 9-1-1 infrastructure account established in [section 10] may be  
8 expended by the department through a grant to a local government working with a private telecommunications  
9 provider for next-generation 9-1-1 infrastructure.

10 (2) For the purposes of [section 10] and this section, the following definitions apply:

11 (a) "ESInet" means an emergency services IP network. It includes the IP infrastructure on which  
12 independent application platforms and core functional processes are deployed.

13 (b) "IP" means internet protocol, or the method by which data are sent on the internet, or a  
14 communications protocol for computers connected to a network, especially the internet.

15 (c) "Next-generation 9-1-1 infrastructure" means a statewide ESInet, upgrades and replacement of  
16 existing selective routers with IP routers, and upgrades to all non-IP-capable public safety answering points for  
17 IP capability.

18 (3) In making grant awards under this section, the department shall give preference to local governments  
19 working with private telecommunications providers that the local government determines can most effectively  
20 implement infrastructure improvements.

21 (4) The department shall consult with and consider recommendations by the 9-1-1 advisory council  
22 established in [section 1] for awards made under this section.

23 (5) The department may adopt rules to administer the provisions of [section 10] and this section. The  
24 rules must ensure that all local governments are treated equitably and must include but are not limited to  
25 provisions regarding:

26 (a) applications;

27 (b) timelines;

28 (c) eligibility, including proof of eligibility;

29 (d) the procedure for establishing the priority of grant awards;

30 (e) the appeal process for grant applications that are denied; and



1 (f) disbursement of grant money to providers.

2 (7) Before September 1, 2018, the department shall report to the energy and telecommunications interim  
3 committee provided for in 5-5-230 on efforts to distribute grants in accordance with [section 10] and this section.

4 (8) Before September 1, 2019, the department shall produce a report summarizing the grants provided,  
5 how the grant money was spent, and the program data and information reported by grant recipients. The  
6 department shall provide the report to the energy and telecommunications interim committee.

7  
8 **NEW SECTION. Section 12. 9-1-1 GIS mapping account created -- source of funding -- use of**  
9 **account.** (1) There is an account in the state special revenue fund to be known as the 9-1-1 GIS mapping fund.

10 (2) There must be deposited in the account:

11 (a) money received from legislative allocations;

12 (b) a transfer of money by the department in accordance with [section 9(1)(b)] for use in accordance with  
13 subsection (3) of this section; and

14 (c) any gift, donation, grant, legacy, bequest, or devise made for the purposes of subsection (3).

15 (3) The account may be used only by the state library provided for in 22-1-102 in carrying out its land  
16 information and management duties to award a contract in accordance with 18-1-102 to assess the status of GIS  
17 adoption and operations in Montana as they pertain to next-generation 9-1-1.

18 (4) Before September 1, 2018, the state library shall produce a report summarizing the status of GIS  
19 adoption and operations in Montana as they pertain to next-generation 9-1-1, including policy and funding  
20 recommendations necessary to use GIS to advance next-generation 9-1-1. The state library shall provide the  
21 report to the energy and telecommunications interim committee provided for in 5-5-230.

22 (5) At the end of fiscal year 2019, any unexpended balance in the account must be transferred to the  
23 account established by the department in accordance with [section 6(2)(b)].

24  
25 **NEW SECTION. Section 13. Statewide 9-1-1 planning account created -- source of funding -- use**  
26 **of account.** (1) There is an account in the state special revenue fund to be known as the statewide 9-1-1  
27 planning account.

28 (2) There must be deposited in the account:

29 (a) money received from legislative allocations;

30 (b) a transfer of money by the department in accordance with [section 9(1)(c)] for use in accordance with

1 subsections (3) through (5) of this section; and

2 (c) any gift, donation, grant, legacy, bequest, or devise made for the purposes of subsections (3) through  
3 (5).

4 (3) The account may be used only by the department to award a contract in accordance with 18-1-102  
5 and after consulting with the 9-1-1 advisory council created in [section 1] to develop a statewide 9-1-1 plan.

6 (4) A statewide 9-1-1 plan must include proposed:

7 (a) priorities for 9-1-1 systems in Montana and plans for next-generation 9-1-1 technology deployment;

8 (b) potential formulas and methods to distribute 9-1-1 money;

9 (c) uniform standards relating to technology, next-generation 9-1-1 technology, and administration and  
10 operation of 9-1-1 systems in Montana;

11 (d) steps to promote collaboration among local governments and greater incentives for cooperation  
12 among local governments and public safety answering points to improve efficiency by developing interconnectivity  
13 of 9-1-1 systems through partnerships for enhancement, operation, and maintenance of the network;

14 (e) eligible uses for money received by local governments in accordance with this chapter;

15 (f) audits or other steps necessary to ensure program compliance from entities receiving disbursements  
16 in accordance with this chapter;

17 (g) necessary plans to include, to the maximum extent feasible, the use of existing commercial  
18 communications infrastructure; and

19 (h) additional changes needed to this chapter to migrate legacy 9-1-1 systems and to accommodate  
20 evolving, future 9-1-1 technologies.

21 (5) Before September 1, 2018, the 9-1-1 advisory council shall review the proposals and make its  
22 recommendations to the department on implementing the recommendations.

23 (6) At the end of fiscal year 2019, any unexpended balance in the account must be transferred to the  
24 account established by the department in accordance with [section 6(2)(b)].

26 **Section 14.** Section 10-4-101, MCA, is amended to read:

27 **"10-4-101. Definitions.** As used in this chapter, unless the context requires otherwise, the following  
28 definitions apply:

29 (1) ~~"Allowable costs" means the actual costs associated with upgrading, purchasing, programming,  
30 installing, testing, operating, and maintaining data, hardware, and software necessary to comply with federal~~

2 ~~———(2) "Basic 9-1-1 account" means the 9-1-1 emergency telecommunications account established in~~

4 ~~———(3) "Basic 9-1-1 service" means a telephone service meeting the standards established in 10-4-103 that~~  
5 ~~automatically connects a person dialing the digits 9-1-1 to an established public safety answering point.~~

6 ~~———(4) "Basic 9-1-1 system" includes equipment for connecting and outswitching 9-1-1 calls within a~~  
7 ~~telephone central office, trunking facilities from the central office to a public safety answering point, and~~  
8 ~~equipment, as appropriate, that is used for transferring the call to another point, when appropriate, and that is~~  
9 ~~capable of providing basic 9-1-1 service:~~

10 (1) "9-1-1 system" means telecommunications facilities, circuits, equipment, device, software, and  
11 associated contracted services for the transmission of emergency communications. A 9-1-1 system includes the  
12 transmission of emergency communications:

13 (a) from persons requesting emergency services to a primary public safety answering point and  
14 communications systems for the direct dispatch, relay, and transfer of emergency communications; and

15 (b) to or from a public safety answering point to or from emergency service units.

17 (a) a mobile service that is:

18 (i) provided for profit with the intent of receiving compensation or monetary gain;

19 (ii) an interconnected service; and

20 (iii) available to the public or to classes of eligible users so as to be effectively available to a substantial  
21 portion of the public; or

22 (b) a mobile service that is the functional equivalent of a mobile service described in subsection ~~(5)(a)~~

23 (2)(a).

24 ~~(6)(3) "Department" means the department of administration provided for in Title 2, chapter 15, part 10.~~

25 ~~(7) "Direct dispatch" means a 9-1-1 service in which a public safety answering point, upon receipt of a~~  
26 ~~telephone request for emergency services, provides for a decision as to the proper action to be taken and for~~  
27 ~~dispatch of appropriate emergency service units:~~

28 (4) "Emergency communications" means the transmission of voice, video, or electronic data involving  
29 the safety of human life or protection of property from one device to another.

30 ~~(8) "Emergency" means an event that requires dispatch of a public or private safety agency.~~

1           ~~(9)~~(5) "Emergency services" means services provided by a public or private safety agency, including law  
2 enforcement, firefighting, ambulance or medical services, and civil defense services.

3           ~~(10)~~ "Enhanced 9-1-1 account" means the 9-1-1 emergency telecommunications account established  
4 in ~~10-4-301(1)(b)~~.

5           ~~(11)~~ "Enhanced 9-1-1 service" means telephone service that meets the requirements for basic 9-1-1  
6 service and that consists of selective routing with the capability of automatic number identification and automatic  
7 location identification at a public safety answering point enabling users of the public telecommunications system  
8 to request emergency services by dialing the digits 9-1-1.

9           ~~(12)~~ "Enhanced 9-1-1 system" includes customer premises equipment that is directly related to the  
10 operation of an enhanced 9-1-1 system, including but not limited to automatic number identification or automatic  
11 location identification controllers and display units, printers, and software associated with call detail recording,  
12 and that is capable of providing enhanced 9-1-1 service.

13           ~~(13)~~(6) "Exchange access services" means:

14           (a) telephone exchange access lines or channels that provide local access from the premises of a  
15 subscriber in this state to the local telecommunications network to effect the transfer of information; and

10           (2) [Sections 6 through 13] are intended to be codified as an integral part of Title 10, chapter 4, part 3,  
and the provisions of Title 10, chapter 4, part 3, apply to [sections 6 through 13].

12           NEW SECTION. Section 26. Saving clause. [This act] does not affect rights and duties that matured,  
13 penalties that were incurred, or proceedings that were begun before [the effective date of this act].

14

15           NEW SECTION. Section 27. Severability. If a part of [this act] is invalid, all valid parts that are  
16 severable from the invalid part remain in effect. If a part of [this act] is invalid in one or more of its applications,  
17 the part remains in effect in all valid applications that are severable from the invalid applications.

18

19           NEW SECTION. Section 28. Effective dates. (1) Except as provided in subsection (2), [this act] is  
20 effective upon passage and approval.

21

(2) [Sections 14 through 16, 20, and 22] are effective July 1, 2018.

23           NEW SECTION. Section 29. Termination. [Sections 9 through 13] terminate October 1, 2019.
